



## **Park Regulations**

## Welcome!

The Grand Garden of Dresden is a significant international monument to architecture and garden design.

Please help us preserve the park as a place of culture and recreation!

Please be aware of the following:

You enter the park at your own risk. In particular, remain alert to uncontrolled breakage of green branches and dangers caused by severe weather events. Liability for damage is excluded to the extent permitted by law. Please note that not all paths are illuminated. Only limited winter service is provided. Paths that have not been cleared or gritted are not open to the public.

In the interest of everyone, the instructions of the supervisory staff and the employees of State Palaces, Castles and Gardens of Saxony, non-profit, must be followed. Everyone visiting The Grand Garden of Dresden is to act in such a manner that people are not placed at risk and the park's features and buildings are not damaged. Please help us to keep the garden area clean by taking your waste along with you or disposing of it in the provided waste bins.

Bicycles, e-scooters, roller skates, skateboards, inline skates, rickshaws or Segways are only permitted on the asphalt paths, whereby pedestrian traffic always has priority. Motor vehicles are only permitted to enter with a special permit. The applicable speed limit of 20 km/h (12,42 miles/h) and the road traffic regulations must be observed by vehicles of any kind.

The Dresden Park Railway, which runs in The Grand Garden of Dresden, always has right of way. All road traffic may only approach the level crossings at moderate speed. Pedestrians must wait at a safe distance in front of the level crossing when a rail vehicle is approaching. You must not ignore the instructions of the railroad staff.

Dogs must be kept on a short leash, and dog's excrement must be removed immediately.

Attention: Areas of water surface, wells and fountains do not contain drinking water!





## You are also forbidden to:

- leave paths and enter the green areas with the exception of the designated sunbathing lawn found near the open-air stage on the corner of Karcherallee and Tiergartenstraße
- park without special permission
- damage facilities, constructions, other park facilities and plants, to contaminate them or to remove them from their locations
- climb on sculptures, balustrades, fountains, trees or horticultural facilities
- picnic or spend the night on green spaces
- set up gazebos, awnings, hammocks, slacklines or similar structures
- use open fires, in particular to barbecue or set off fireworks
- consume drugs
- play ball or sports games, go horse riding, skiing, tobogganing or participate in any form of commercially-organized sports in the facility
- practice Nordic walking with pointed poles
- bathe in the waters and fountains (this also applies to pets), to fish or to operate model boats
- walk, skate or drive on ice surfaces
- make noise, in particular to make or play loud music
- put up advertising boards, posters or signs, place or distribute flyers, leaflets, advertising brochures or other printed materials
- engage in trade or commerce without the written permission of State Palaces, Castles and Gardens, non-profit
- film or photograph for commercial purposes without the written permission of State Palaces, Castles and Gardens, non-profit
- fly drones or other remote-controlled aircraft
- present musical or artistic performances without the written permission of State Palaces, Castles and Gardens, non-profit
- feed wild animals

Violations may be punished as an administrative offense.
